

Why do we need "tabloid" news angles?

• Boring news angles are actually **riskier**

 \rightarrow It can lead to misleading stories



• We have to carry that responsibility



It comes down to two things...

1. Agreeing on a target audience

2. Facilitate a better dialogue much earlier in the process



1. Agreeing on a target audience

- Implemented a target audience strategy in the business strategy
- Every dissemination product must be aimed at one target audience

Government deficit for the first time in 25 years

The figures are uncertain and may be revised, but as of now we have a quarter with a deficit in public administration. In that case, it is the first time this has happened since 1994," says Head of National Accounts Pål Sletten.

Norges brutto nasjonalinntekt falt 9 prosent fra 1. til 2. kvartal 2020. Samlet sparing for Norge falt markert, og underskuddet i offentlig forvaltning var det høyeste siden midten av 1990-tallet. Samtidig var husholdningenes sparerate historisk høy.

Målt i løpende priser tilsvarer nedgangen i brutto nasjonalinntekt (BNI) 15 500 kroner per innbygger, justert for normale sesongsvingninger^{III}. Nedgangen skyldes først og fremst at bruttonasjonalproduktet falt med 8,7 prosent i 2. kvartal. I tillegg falt netto lønn- og formuesinntekter fra utlandet.

 Tallene er usikre og kan bli revidert, men slik de står nå ser vi sannsynligvis et kvartal med underskudd i offentlig forvaltning. Det er i så fall første gang siden 1994, sier seksjonssjef for Nasjonalregnskap Pål Sletten.

 Statens inntekter har falt, og utgiftene har gått opp. Dermed har det offentlige skjermet privat sektor fra størsteparten av nedgangen i nasjonalinntekten.
Motstykket er at staten for første gang på svært lenge går fra sparing til underskudd, sier Sletten.
